RE: Fertitta false information on 25 FEC receipts

Dear Associate General Counsel Kitcher and OGC Staff,

We write to bring to your attention 25 FEC Form 3X itemized receipts submitted with false information about employer and occupation totaling \$756,300 in contributions from Lorenzo Fertitta and Frank Fertitta III to 11 FEC registered entities between 2019 and 2021. We ask you determine whether this false information was knowingly submitted in violation of Title 52 of the US Code on voting and elections.

FEC Form 3X Report of Receipts and Disbursements says "Submission of false, erroneous, or incomplete information may subject the person signing this Report to the penalties of 52 U.S.C. § 30109." The Federal Election Campaign Act US Code says the treasurer of a political committee shall keep an account of "the identification of any person who makes a contribution or contributions aggregating more than \$200 during a calendar year, together with the date and amount of any such contribution" [52 U.S.C. § 30102(c)(3)] and defines identification as "in the case of any individual, the name, the mailing address, and the occupation of such individual, as well as the name of his or her employer" [52 U.S.C. § 30101(13)].

Lorenzo Fertitta's FEC receipts from 2019 and 2021 lists his employer as the Ultimate Fighting Championship (UFC) with occupation as Chairman of the Board or CEO, and receipts from 2019 lists Lorenzo's employer as Zuffa LLC, the UFC parent company, with occupation as CEO or Owner. One Lorenzo Fertitta FEC receipt from 2019 shows employer as Fertitta Entertainment LLC with occupation as Chairman and CEO. Frank Fertitta's FEC receipts from 2019 lists his employer as UFC parent company Zuffa LLC with occupation as owner, and receipts from 2019-2021 list Frank's employer as Fertitta Entertainment LLC with occupation as chairman and CEO, and in one instance, owner.

This information in those FEC receipts is outdated and, as a result, false.

Lorenzo Fertitta and Frank Fertitta III were co-owners of the Ultimate Fighting Championship via its parent company, Zuffa LLC, until the UFC was <u>sold to new owners in 2016</u>. According to SEC filings in <u>2019</u>, <u>2020</u> and <u>2021</u>, Lorenzo and Frank co-owned Zuffa LLC until it was sold in August 2016, and

Lorenzo was Zuffa LLC chairman and CEO until August 2016.² Lorenzo and Frank sold their remaining minority stake in the UFC in <u>September 2017</u>.³

Lorenzo and Frank Fertitta were co-owners of Fertitta Entertainment until the time it was acquired by Station LLC in May 2016, according to SEC filings in 2019, 2020 and 2021. According to an SEC filing in 2017, Red Rock Resorts, Inc. in 2016 terminated the management agreements between Red Rock Resorts, Inc. and Fertitta Entertainment and entered into new employment agreements with its executive officers including Frank J. Fertitta III.⁴ By March 2017, Fertitta Entertainment was listed as a subsidiary of Red Rock Resorts, a Fertitta-controlled company that owns and operates Station Casinos.⁵

We ask that you make a determination as to who might be responsible for submitting false information and whether this was done knowingly.

For your reference we have included information below about each itemized receipt and the corresponding FEC Form 3X. Please email me if you want this shared electronically. We have included a spreadsheet and screenshots also for your reference.

Mr. Fertitta also served as President of STN from July 2000 until June 2008. Mr. Fertitta was also the co-owner of Fertitta Entertainment until the time it was acquired by Station LLC in May 2016 and the co-owner of Zuffa, LLC until it was sold in August 2016 and served as Chairman and CEO of Zuffa, LLC from June 2008 until August 2016. From 1991 to 1993, he served as Vice President of STN. Mr. Fertitta served as President and CEO of Fertitta Enterprises, Inc. from June 1993 to July 2000, where he was responsible for managing an investment portfolio consisting of marketable securities and real property. Mr. Fertitta served as a member of the board of directors of the Nevada Resort Association from 2001 to 2008. Mr. Fertitta served as a director of the American Gaming Association from December 2005 to May 2008 and as a commissioner on the Nevada State Athletic Commission from November 1996 until July 2000.
